Mix 1, heat to  $75^{\circ}$ C / Mix 2, heat to  $75^{\circ}$ C, add to 1 while stirring, homogenise, cool to  $40^{\circ}$ C / Add the remaining ingredients separately while stirring, homogenise / Cool to  $25^{\circ}$ C while stirring

Stability: Stable for more than 3 months at 5°, 25°, 40°C
