Mix 1 / Sprinkle 2 on the surface, wait until the powder is fully saturated, mix thoroughly until completely smooth / Mix 3 while stirring / Add 3 to 1 & 2 while stirring, homogenise / Add 4 to 1-3 while stirring, homogenise / Add 5 and 6 while stirring, homogenise.
