Mix 1, heat to  $50^{\circ}$ C, all ingredients must be solved / Add 2 to 1 in little portions while stirring / The phase must be homogenous / Add 3 and 4 separately while stirring / Mix 5, add while stirring, the product is getting white / Mix 6, add while stirring, cool to RT while stirring

Stability: Stable for more than 3 months at 5°, 25°, 40°C
