Prepare 1 / Mix 2, add to 1 while stirring, heat to 70°C / Mix 3, heat to 70°C, add to 1/2 while stirring / Add 4 while stirring, homogenise / Cool to 40°C while stirring / Add the remaining ingredients separately while stirring, homogenise / Cool to 25°C while stirring

**Stability:** Stable for more than 3 months at 5°, 25°, 40°
